**This MOU is made on- 10 May, 2023**

This GSG College was started 56 years ago by local farm community as they saw the need for a college in this underdeveloped area. In the beginning when this college was started, they did not have facility of their own so they were conducting morning classes in a local high school.

Dr. Atmaram Gawande, who is born in this area and had gone to high school in Umarkhed saw the opportunity to help the community in their educational endeavor. In the year 1985, Dr. Sushila and Dr. Atmaram Gawande provided the seed money to build the college. To honor Dr. Gawande's mother, this college is now named Gopikabai Sitaram Gawande. The Government of Maharashtra gave the land to build the college, the local community and farmers collected the funds and a small college building is now built over several years.

This is a premier institution for imparting formal education in the science stream and is affiliated with Sant Gadge Baba Amravati University, Amravati. The college offers Junior, under Graduate, Post Graduate, Research level education, Career Oriented Courses and B.Voc. Courses are also the part of the faculty of Science. The college is re-accredited by NAAC with 'B++' Grade with a CGPA of 2.79 (Third Cycle). The College has also earned a special reputation for being conferred with the status of a "College with potential for Excellence" by the UGC for second phase. The college is identified by DST, Govt. of India for FIST and Sant Gadge Baba Amravati University as lead College.

### **Protection of Intellectual Property Rights:**

Jointly by the parties or research result obtained through the joint activity effort by the parties shall be jointly owned by the parties in accordance with the terms to be mutually agreed upon and

The terms and condition in the execution of the social work projects shall be decided on case to case basis.

## Revision Modification and Amendment:

Either party may request in writing a revision, modification or amendment or all or any part of this Memorandum of Understanding.

Any revision, modification or amendment agreed to by the parties shall be reduced into writing and shall form part of this Memorandum of Understanding.

Any revision, modification or amendment shall not prejudice the rights and obligations arising from or based on this Memorandum of Understanding Prior or up to the date of such revision, modification or amendment.

## Entry into Force Duration and Termination:

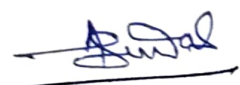
