### **1. Objective**

The objective of this MOU is to express the willingness of both institutes to engage in an effort to promote the development of research activities as well as to develop and expand relationships between two departments of two institutes for the benefit of research students to inculcate the research aptitude in the minds of research-oriented students. Specific research activities under this MOU will be identified through discussions between the two authorities.

*The Principal, Gopikabai Sitaram Gawande Mahavidyalaya, Umarkhed and The Principal Dayanand Science College, Latur are hereby agrees to provide every possible assistance to carry out research activities in its parent institutes, that will improve or expand the support for the students and faculty of Botany engaged in research activities and improve the quality of research by providing access to the Laboratories, Instruments, Chemicals and Literature available in the institute and also review in terms of progress of the research students. Finding the good results on the basis of interest of students in research,*

**Gopikabai Sitaram Gawande Mahavidyalaya, Umarkhed and Dayanand Science College, Latur can further extend its support for specific activities which may further be developed through a participatory process. After finalizing the strategic planning, technical support for research activities, agreements between the two institutes will be finalized further through a participatory process. These agreements will be detailed in subsequent Addendums of this MOU.**

Yavatmal and Department of Microbiology, Dayanand Science College, Latur agree to work in coordination with the development of their initiatives to improve and expand support in research activities. They also agree to allow the carrying out research activities to assess its impact on participating students and faculty at large.**





## **2. General Terms of MOU**

### **1. Duration of MOU:**

This MOU shall be operational upon signing and will have an initial duration of **five** year. All activities conducted before this date within the vision of the joint collaboration will be deemed to fall under this MOU.

### **2. Coordination:**

In order to carry out and fulfil the aims of this agreement, both institutes will appoint an appropriate person(s) to represent its organization and to coordinate the implementation of activities and will meet regularly to discuss progress and plan activities.

### **3. Termination of MOU:**

The partnership covered by this MOU shall terminate upon completion of the agreed upon period or at the end of five years from the date of signing. The agreement may also be terminated with a written one month notice from either side.

### **4. Extension of Agreement:**

The memorandum of understanding may be extended provided both the institutes agree upon and can provide the necessary resources.

### **5. Communications:**

All communication under this agreement in connection herewith shall be written in English language, communicated through proper channels either through Head of Department and Principal of College.

### **6. Addendum:**

Any Addendum to this MOU shall be in writing and signed by both institutes.





**7. Rights:**

Both the institutes shall have equal rights or rights proportionate to contribution in project whichever applicable on the research outcomes produced during MOU duration.

8. The terms and provisions in this MOU also apply to any subsequent Addendum to this agreement.






