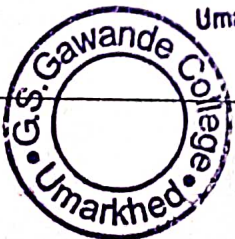

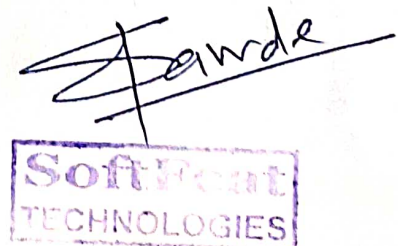

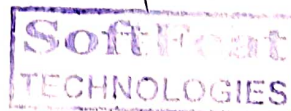

### Clause 3

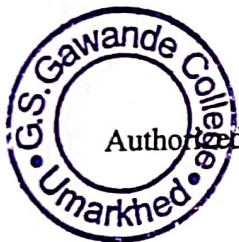
#### VALIDITY


